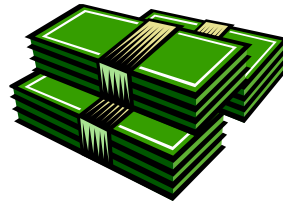
Make an irrevocable tax-deductible donation to APCF. (Minimum contribution of \$1,000)

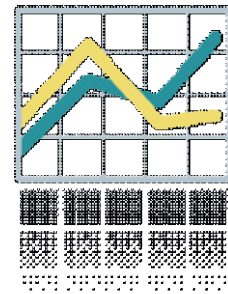


2. **Grow Your Contributions Tax-Free**

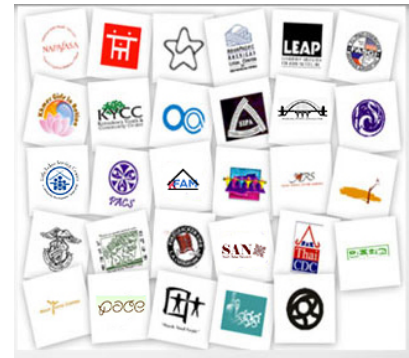


3. **Grant Making**
